

**SEPTEMBER ELEVENTH FABLE**

There was a time when we believed that leaders protected our interest because they were the same, but now there is a credibility crisis believing any leader, plan and inconsistent, official stories in support of agendas; stories - fables heralded by the machinery of government passed along as truth. Yet it's true that official stories serve as damage control, hiding incompetence at best, and conspiracies at worst.



Democracy has been usurped by the military-industrial complex whose agents are in institutional positions to engineer chaos - to keep citizens from investigating the “classified” workings of intelligence agencies and their relationships to all the actors of profitable war – including the murky role of terrorists. The war on terrorism is a fear driven model of power in the guise of democracy forced to finance the business of peace. Since people believe in hearing more than what they see, mind manipulators of state craft fables - simple story lines meant to replace an uncertain memory with a new memory.

The Fable of September 11<sup>th</sup> has been institutionalized with heartfelt rhetoric and “*moments of silence*” for the innocent killed - genuine stories of loss which no music or words can assuage. But, the stage production of moments of silence at Ground Zero cloaking the official story in patriotism, and eulogies of the innocent paraded as truth, excludes any genuine questioning of what is a fable when it ignores who, what and why the attacks occurred. But this eulogy of staged manipulations is a lie when liberty is imprisoned by a silenced truth. One might quietly conclude that with the passage of the Patriot Act, the Bill of Rights, given its forced retirement from civil society, is a list of what one will suffer if they protest too much for a change in the storyline. But despite the hidden intentions of having an official fable, still the truth haunts those who would write it off.

Society is always in a state of change, but the allegation is, society has been altered by engineered chaos of fear. Yet one thing has not changed – misguided politicians and bureaucrats compulsively focused on “*war making*” whose unfettered nature obstructs transparency that requires an end to secrecy of state; an engineered state of paralysis that cloaks power not interested in being held accountable for possible criminal acts against the citizenry.

Commissions need to ask questions that are thought, but are afraid to speak; allegations of functionaries within government doing staged political crimes cloaked by political functionaries and bureaucrats lying to commissions, then courts investigating powerful interests that have every motive to commit economic crimes. But, appointed commissions by design with like minded people - are a conspiracy of sorts – like meddling with the truth; a truth that engineers questions as to the capability of aluminum skinned planes powered by kerosene fuel, aimed not at foundations, not at the spine of the buildings, but at mid point columns; or audio recordings of firefighter reporting explosions below the impact points; or the collapse

of a skyscraper that never sustained a direct hit; nor the grounding of American aircraft while the terrorist's relatives were picked-up by a foreign, private plane. None of these facts and credible views has been fully investigated by a congressional investigation "*with teeth*," to impeach and imprison presidents, their functionaries and bureaucratic collaborators within the intelligence community.

Commissions are in the business of "*white washing*" events by design. The 9/11 Commission functioned as a cover, censoring "*classified information*" revealing incompetence and perhaps secret, incestuous relations between intelligence agencies and powerful finance. This institutionalized relationship between government and the military-industrial complex has no interests in an authentic investigation that might assuage the fears of the conspiracy theorists. Bush functionaries obstructed recorded information to the Commission that described their incompetent actions prior to the attacks.<sup>1</sup> Yet what was the information of unwritten records? Unfortunately, clandestine meetings of the president were interpreted by the Commission and press as evidence of incompetence at the highest levels of government when it pointed to possibilities of a conspiracy to cover-up incompetency, or worse – a hand in it. It can be inferred at a minimum that a series of criminal obstructions occurred to hide "*inside*" knowledge.

Incompetency for certain, yet solely blaming incompetency allows the label of stupidity to be used to avoid accountability; but then most politicians require that to function as deal makers. Yet Commission deal makers failed to investigate who or what else had motives; or how an act may have been staged for what ends. Still, we are left with troubling allegations that imply the possibility of "*an inside job*" committed by terrorists on the payroll of cloaked interests in need of war. This persistent allegation is why most of the Commission members are unsatisfied with their own investigation into ugly bureaucratic and political interests suffered under the Bush regime; and continual executive obstructions by Obama only give further credence to the belief that hidden parties within the military industrial complex somehow were involved in the attacks.

What should we do when leaders, bureaucrats, and a system with a life of its own, whose instruments may be under the influence of secret organizations, dine at the expense of society, are too engorged on the vanities of power, talk too much and never think twice about asking citizens to die for them? It's an old tale where the best of humanity finds itself on opposing sides staged by others – well meaning people directly facing one another before a congressional investigation into unavailable "*classified information*" revealing corrupted truth. The ancients tell of such tales - certainly we do too. The answer has always been found in studying allegations, reflecting the impact of "*doctored*" governmental stories on a public increasingly distrustful, then moral action to correct non-accountability from agencies engaged in classifying their acts and methods beyond public review. If government has become corrupted beyond redemption as President Eisenhower warned, then know that there is a large lynch mob outside – the awakened citizens. And to correct the situation there is nothing more certain to win them over than the sight of a chief doing penitence and humbling him under punishment. Because truth is a very good thing - and all things considered one gains by having it on one's side. Our dear departed friends call us to say so. But since leaders, and certainly bureaucrats won't acknowledge truth, in congressional councils, we ought to determine what punishments leaders, functionaries and collaborators ought to receive - for justice demands they be sought out – one may be sure of it. It is a time for all within government to do penitence.
