

WAR ON CITIZENS

The National Defense Authorization Act, or [H.R. 1540](#) is traveling in the guise of public safety, but really are designed to protect an economic and political system defined, controlled by the parasitic relationships between powerful finance in the form of the prison and military industrial complexes. In the language being crafted, there are provisions to empower the police state to further spy upon an anxious public reacting to their oppressed condition. George Orwell warned us of the use of deadly, deceptive language of state that exploits the powerless in both its domestic and international games of high finance. The definitions of violent radicalization and homegrown terrorism in proposed national security bills use ambiguous language that defines this term as promoting any belief system that the government considers to be extremist. But with Orwellian obscuration of words, the national security bill fails to define what an extremist belief system is. Unfortunately, the interpretation, or manipulation of language is left to government technocracies managed by dependent bureaucrats and in some cases, vile people “*peddling*” militarism, pseudo-science, or the odor of goodness of government directed faith based community initiatives “*pushing*” puritanical religious values necessary to continue the business of moral entrepreneurship. To quell public concerns, proposed national security legislation will create an incestuous commission composed of politicians and technocrats for the prevention of ideological based radicalized violence. The appointed foxes guarding the henhouse of cackling dissenters are the authoritarian bureaucrats with no credible accountability as to abusing the perverse right to spy on your thoughts. Elite senators on behalf of the financial interests of cloaked oligarchs need to control political discussions which they want to outlaw. But legalized surveillances of the mind will lead to legalized tyranny of what are “*appropriate*” and “*inappropriate*” thoughts outlined in national security legislation of how the government is going to defeat violent radicalization and homegrown terrorism with international cooperation informed by the demands of finance. The government will seek the advice of countries to determine how to deal with what has been labeled as thought crime; something like consulting with European experts at oppressing rebellions.
